WAGES COUNCIL ACT 1959

BOOT AND SHOE REPAIRING WAGES COUNCIL (GREAT BRITAIN)

THE VEHICLE AND DRIVING LICENCES ACT 1969 (Commencement No. 5 Order 1970 (S.I. 1970 No. 169) (C.4)

The Motor Vehicles (Driving Licences) Regulations 1970 (S.I. 1970 No. 170)

- 1. THE Minister of Transport laid before Parliament on 16th February 1970 the above Commencement Order and Regulations.
- 2. The Commencement Order brings into operation certain sections of the Vehicle and Driving Licence Act 1969 which amend the law as it affects the licensing of drivers. The Order comes into operation on 1st June 1970 except in the case of section 27 (admissibility of certain records) which will enter into force on 1st April 1970.
- 3. The purpose of the Regulations which come into operation on 1st June 1970 is as follows:
 - i. to introduce changes in groups of vehicles for driving test purposes;
 - ii. to introduce the change in driver licensing procedures for which statutory authority is given in the Vehicle and Driving Licences Act 1969; and
 - iii. to consolidate, with some further amendments, the remainder of the Motor Vehicles (Driving Licences) Regulations 1963 as amended.

Grange Burn Flood Prevention Scheme 1969

The Scheme will entail the construction of a Flood Relief Channel of overall width of 70 feet or thereby, having a cross section of trapezoidal form with raised flood banks, commencing at the north end of Beancross Culvert on the A.905 thence in an easterly direction for a distance of 1,900 feet or thereby to the existing Inchyra Road Culvert, thence in a north easterly direction for a distance of 1,400 feet or thereby to a point approximately 350 feet south west of the Inchyra Road/Wholeflats Road junction, thence in a generally easterly direction via the existing Grange Road culvert along the north side of the Burgh Boundary of the Burgh of Grangemouth to outfall to the River Avon.
