THE TRUNK ROADS (KIRKOSWALD)  
(PROHIBITION OF WAITING) ORDER 1970

THE Secretary of State proposes to make an order which will prohibit vehicles from waiting between May and September each year on lengths of the trunk road (Route A.77) in Kirkoswald, Ayrshire, as follows: (1) On both sides of the road from a point approximately 155 yards west of Cairnhill Place westwards for approximately 117 yards and (2) on the south side of the road from Kirkgate westwards for approximately 20 yards. Exceptions would permit waiting for the purposes of:

- a. picking up and setting down passengers
- b. loading and unloading goods

Where necessary, in connection with:

- c. the maintenance of the roads, and
- d. the supply of gas, electricity and water.

Disabled drivers would not be affected by the proposals.

Full details of these proposals are in the draft order which together with a map showing the restricted lengths of road and a statement of the Secretary of State's reasons for proposing to make the order may be examined during normal office hours at:
