

#### RETAIL FURNISHING AND ALLIED TRADES WAGES COUNCIL (GREAT BRITAIN)

THE Retail Furnishing and Allied Trades Wages Council (Great Britain) hereby gives notice of its intention to submit to the Secretary of State for Employment and Productivity proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Retail Furnishing and Allied Trades) Order 1967 (Order R.F.A.(48)) as amended by the Wages Regulation (Retail Furnishing and Allied Trades) (Amendment) Order 1968 (Order R.F.A. (50)); and (2) the revocation of Order R.F.A.(48) and Order R.F.A.(50).

#### PRICES AND INCOMES ACT 1966 MARGARINE AND COOKING FATS (SHORTENINGS)

Direction under Section 5(4) Extending the period within which the National Board for Prices and Incomes must publish their Report

WHEREAS the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Agriculture, Fisheries and Food, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, referred the above-mentioned question to the National Board for Prices and Incomes for examination and have published the text of the reference in the Gazette on 3rd February 1970;

And whereas by section 5(3) of the Act, but subject to section 5(4), the Board are required to make their report so as to allow publication within three months of the said date;

Now, therefore, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Agriculture, Fisheries and Food, in pursuance of their powers under the said section 5(4), hereby direct that the said period of three months be extended by one month. The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 21 days from 28th April 1970. Any such representation should bear the writer's address and signature and be sent to the Secretary, Retail Furnishing and Allied Trades Wages Council (Great Britain), 12 St. James's Square, London S.W.1. It is desirable that persons making objections should state the precise nature of their objections, and quote the number of the Wages Council's Notice of Proposal R.F.A.(51).
