THE COUNTY COUNCIL OF THE COUNTY OF PEEBLES

(Restricted Roads) (No. 1) Order, 1970

- 1. ON 28th April 1970, the County Council of the County of Peebles, after consultation with the Chief Constable of The Lothians and Peebles and with the consent of the Secretary of State, made the above-named Order under Section 72(3) and Section 73(1) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968.
- 2. This Order will come into operation on 18th May 1970, and the effect of the Order is that each of the following lengths of road shall cease to be subject to a speed limit of 30 m.p.h.:
- (a) the section of the Edinburgh-Moffat Road A.701 at the north end of Broughton Village from the existing signs near Broughton Place Roadend southwards for a distance of 150 lineal yards; and
- (b) the section of the above road at the south end of Broughton Village from the existing signs near the house known as Rachanside northwards for a distance of 201 lineal yards.

Any person who wishes to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may, within six weeks from 28th April 1970, apply to the Court of Session for this purpose.
