TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 19th June 1970, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £120,000,000.
2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 22nd June 1970, to Friday, the 26th June 1970, inclusive, and will be due 91 days after date.
3. The Bills will be issued and paid at the Bank of England.
4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be Discount House or Broker.
6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
5. Tenders must be made through a London Banker, lodged for Bills of different dates.
7. Members of the House of Commons are not precluded from tendering for these Bills.
8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

(2) THE BURGH OF LERWICK (CHARLOTTE STREET AND COMMERCIAL STREET)

(PROHIBITION OF ENTRY) ORDER 1970

THE Town Council of Lerwick propose to make Orders under Section 1(1)(2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

When Order (1) above comes into effect vehicles will be prohibited from driving on Commercial Street, Lerwick, between Leog Lane and the access from Esplanade by the Clydesdale Bank.

Exceptions will permit:

- The conveyance of persons, goods or merchandise to or from premises situated in the street.
- For building or demolition operations.
- For maintenance and cleansing of the road.
- For the laying or maintenance of sewers and gas, electricity, water and telephone services.

When Order (2) above comes into effect vehicles will be prohibited from entering Commercial Street from Charlotte Street and vice versa.

THE CORPORATION OF GLASGOW

(Traffic Regulation) (University Precinct) Order 1970

THE Corporation of the City of Glasgow, on 11th June 1970, made the above Order under Section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968. The Order will come into operation on 22nd June 1970, and its effects will be:—

1. To introduce restriction on waiting by vehicles between 8 a.m. and 6.30 p.m. on Mondays to Fridays and between 8 a.m. and 1 p.m. on Saturdays, and a ban on loading and unloading of vehicles between 8.15 a.m. and 9.15 a.m. from Mondays to Saturdays and between 4.15 p.m. and 6.30 p.m. from Mondays to Fridays in the following roads, viz.:—
 - (a) the north side of University Avenue from a point 140 feet west of the west kerblineline of Ashton Road eastwards to the south kerblineline of Gibson Street;
 - (b) the south side of University Avenue (i) from a point 140 feet west of the west kerblineline of Ashton Road eastwards to a point 140 feet east of Ashton Road; (ii) from a point 140 feet west of Hillhead Street eastwards to a point 140 feet east of Hillhead Street; (iii) from the west kerblineline of Kelvin Way westwards for a distance of 140 feet;
 - (c) the east side of University Avenue from Kelvin Way northwards to the south kerblineline of Gibson Street;
 - (d) Gibson Street (both sides) from the east kerblineline of Bank Street/University Avenue eastwards for a distance of 140 feet.
2. To prohibit waiting by vehicles at all times in University Gardens (upper carriageway) along the south-west kerb;
3. To introduce restrictions on waiting by vehicles between 9.30 a.m. and 4 p.m. from Mondays to Fridays and between 9.30 a.m. and 1 p.m. on Saturdays on the south-west side of Ashton Road from a point 140 feet east of the east kerblineline of Byres Road to the north kerblineline of University Avenue (in addition to the existing restrictions at peak hours);
4. To introduce a system of one-way traffic in a clockwise direction in University Gardens.

APPENDIX

The general effects of the Order will be:

1. To designate parking places on the roads specified in Schedule 2 to this notice at which charges may be made for vehicles authorised to be left in these parking places and to impose restrictions on the waiting and in certain cases on the loading and unloading of vehicles on the roads specified in Schedule 1.

2. To fix the maximum number of parking bays i.e. spaces on the carriageway where vehicles may be left in each parking place, to provide that the number and situation of parking bays in each parking place may be determined by the Corporation and to provide that parts of certain parking places shall not be occupied by parking bays.

3. To provide that the parking bays may be used for the leaving of certain classes of vehicles between the hours of 8 a.m. and 6 p.m. on Mondays to Fridays inclusive and between the hours of 8 a.m. and 1 p.m. on Saturdays, any such day not being a public holiday.

4. To provide that the initial charge for leaving a vehicle in a parking place shall be 1s. for two hours and 6d. for one hour and the unexpired time, if any, shown on the parking meter, the total period not to exceed two hours.

5. To provide that an excess charge of 10s. shall be incurred in respect of any vehicle left in a parking place for longer than the period for which payment was made by the initial charge and that the payment of any excess charge incurred shall be made to the Corporation by the seventh day following the day on which the excess charge was incurred.

6. To prescribe the manner in which vehicles shall stand in parking places and to require that every part of a vehicle shall be within the limits of a parking bay.

7. To provide that a traffic warden or parking attendant may remove or arrange for the removal from a parking place of any vehicle in respect of which certain provisions of the order have been contravened or not complied with.

8. To provide that severely disabled drivers may be exempted from payment of parking meter charges.

9. To empower the Corporation to install parking meters at parking places; and

10. To make other incidental provisions.
