Western Area Part Development Plan Amendment No. 13

NOTICE is hereby given that proposals for the alterations to the above Development Plan (hereinafter referred to as "the proposals") were submitted to the Secretary of State on the 30th day of June 1970.

Following the public inquiry into objections lodged with the Secretary of State, the Part Development Plan was approved in April 1964, subject to a number of modifications under terms of the County of Dunbarton (Western Area) Part Development Plan Approval Order 1964. The Secretary of State directed, inter alia, that all reference to widening of the existing main road, Route A.814, be deleted from the Plan and that the Council give further early and careful consideration to the exact routing and timing of a bypass to the village of Cardross. The route of the proposed Cardross Bypass to the north of the village, which is programmed for construction within the next 5 years, is incorporated in the Amendment now submitted. At the eastern end it is to be connected to the Western Bypass of the Vale of Leven at the Dalmoak Interchange and at its western end it will rejoin the line of the present A.814 immediately west of Mollandhu Farm.
