PRICES AND INCOMES ACT 1966

INSTRUCTION TO THE NATIONAL BOARD FOR PRICES AND INCOMES WITHDRAWING THE INSTRUCTION CONCERNING THE PAY OF UNIVERSITY TEACHERS IN GREAT BRITAIN

WHEREAS under Section 3(1) of the Prices and Incomes Act 1966 the Secretary of State for Economic Affairs made an Order (The Prices and Incomes (Continuous Review) (No. 1) Order 1967 S.I. 1967/1581) and by virtue of that Order and in pursuance of their powers under Section 3(2) of the said Act, the Secretary of State for Economic Affairs

and the Secretary of State for Education and Science, acting jointly, instructed the National Board for Prices and Incomes to keep under continuous review the remuneration of the academic staff of universities in Great Britain (the text of the said instruction being published on 2nd November 1967 in the London Gazette and the Edinburgh Gazette):

Now, the Secretary of State for Employment and Productivity and the Secretary of State for Education and Science, acting jointly in pursuance of their powers under Section 3(4) of the said Act of 1966, hereby withdraw the said instruction to the Board.

WAGES COUNCILS ACT 1959

Flax and Hemp Wages Council (Great Britain)

THE Secretary of State for Employment and Productivity hereby gives notice that on 14th July 1970 he made the Offices, Shops and Railway Premises Act 1963 (Exemption No. 9) Order 1970.

This Order continues for a further period of two years, commencing with 1st August 1970, the exemptions granted by the Offices, Shops and Railway Premises Act 1963 (Exemption No. 6) Order 1968.

The Order exempts railway signal boxes which were constructed before 1st August 1964 and which are more than 180 metres from a piped water supply, from the requirement of Section 10 of the Offices, Shops and Railway Premises Act 1963 that water supplied for washing shall be running water. The Order also exempts railway signal boxes constructed before 1st August 1964, where there is a piped water supply within 180 metres but where there are no effective means of heating running water, from the requirements of Section 10 of the Act that clean, running hot and cold or warm water shall be provided for washing. The latter exemption is granted subject to the conditions that clean, running cold water and means of heating water for washing are provided.

EXPLANATORY NOTE

These Regulations amend the National Insurance (Classification) Regulations 1948 by including among the employments in respect of which persons are treated as self-employed persons occasional employment in certain agricultural or horticultural operations.

WAITING RESTRICTIONS ON TRUNK ROADS A.9 AND A.882 IN WICK

THE Secretary of State gives notice that he has made an order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, imposing waiting restrictions on lengths of the trunk roads (route A.9 and A.882) in Wick.

Exceptions permit waiting for the purposes of picking up and setting down passengers, loading or unloading goods, the maintenance of the road, and the supply of gas, electricity and water. The restrictions shall not apply to disabled drivers who are registered with a local authority.
