SPECIAL ROADS ACT 1949

Gourdon Hill and Sillyflatt Diversions Side Roads

THE Secretary of State has made an order for stopping up four lengths of the Perth-Aberdeen-Inverness Trunk Road (A.92) and constructing a new road to connect with a re-aligned length of the trunk road. Kincardine County Council will become the highway authority for the new road.

Copies of the order, the title of which is the Perth-Aberdeen-Inverness Trunk Road (Gourdon Hill and Sillyflatt Diversions Side Roads) Order 1971, have been deposited at the offices of the Scottish Development Department, St. Andrew's House, Edinburgh and may be seen at all reasonable hours.

Any person aggrieved by the order and desiring to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Special Roads Act 1949, or on the ground that any requirement of the said Act of 1949 or of any regulations made thereunder, have not been complied with in relation to the order, may within six weeks of 20th May 1971 apply to the Court of Session for the suspension or quashing of the order or of any provision contained therein.

(Netherton and Milncroft Bridges) Order 1971
