drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.



FIFE COUNTY COUNCIL CLEAN AIR ACT 1956

The Glenrothes No. 2 Smoke Control Area Order 1971

- 1. NOTICE is hereby given that the County Council of the County of Fife, in exercise of the powers conferred on them by Section 11 of the above mentioned Act on the 15th day of May 1971, made an Order entitled "The Glenrothes No. 2 Smoke Control Area Order 1971." declaring the area described in the schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.

Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are:—Anthracite and Semi-anthracite, Briquetted Fuels carbonised in the process of manufacture, Coke, Electricity, Gas, Low Temperature Carbonised Fuels, Low Volatile Steam Coals, Fluidised Char Binderless Briquettes manufactured by the National Coal Board, "Multiheat" Briquettes and "Rexco" Briquettes.
- 3. The Order after confirmation by the Secretary of State will come into operation on the 24th day of January 1972.
- 4. Copies of the Order and of the man referred to therein may be inspected free of charge at the County Council offices at 113 South Parks Road, Glenrothes, during office hours, which are 8.40 a.m. to 5 p.m., Monday to Friday, during the period of six weeks from the 4th June 1971.
