# TRUNK ROADS ACTS 1936 AND 1946 THE PERTH-ABERDEEN-INVERNESS TRUNK ROAD (FOCHABERS BYPASS) (AMENDMENT) ORDER

THE Secretary of State proposes to make an order to amend the Perth-Aberdeen-Inverness Trunk Road (Fochabers Bypass) Order 1951. The effect of the Amendment Order will be that one section of the existing trunk road, due to be detrunked under the 1951 Order, will not be detrunked and that the remaining two sections will be detrunked in separate stages. The section not to be detrunked extends from a point a short distance north west of the junction with Old Inchberry Road to a point at the western access to Gordon Castle and includes the existing bridge over the River Spey. The remaining section to the north west will be detrunked when the first stage of the new bypass road (i.e. the new bridge over the River Spey and associated approach roads) is opened for the purposes of through traffic. The remaining section to the south east will be detrunked when the second stage of the new bypass road (i.e. the eastern section) is opened for the purposes of through traffic.





### FIFE COUNTY COUNCIL THE COUNTY OF FIFE

(High Street and The Wynd Pitlessie One-Way) Traffic Regulation Order 1971
