The QUEEN has been pleased to issue Her Majesty's Letters Patent under the Great Seal of the Realm in the form following:—

ELIZABETH THE SECOND by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Queen Head of the Commonwealth Defender of the Faith to all Archbishops Dukes Marquesses Earls Viscounts Bishops Barons Baronets Knights Citizens and Burgesses and all other Our faithful Subjects whatsoever to whom these Presents shall come Greeting Whereas it is Our intention to be absent from Our United Kingdom for the purpose of visiting the Republic of Turkey And Whereas by the enactments known as the Regency Acts 1937 to 1953 it is (amongst other things) enacted that in the event of Our absence or intended absence from Our United Kingdom We may in order to prevent delay or difficulty in the despatch of public business by Letters Patent under the Great Seal delegate for the period of that absence to Counsellors of State such of Our Royal functions except the power to dissolve Parliament otherwise than on Our express instructions and the power to grant any rank title or dignity of the peerage) as may be specified in the Letters Patent And Whereas the persons described by the said enactments as the Counsellors of State to be named in such Letters Patent are as follows that is to say Our most dearly beloved Husband and most faithful Counsellor Prince Philip Duke of Edinburgh Our most dearly beloved Mother Queen Elizabeth the Queen Mother Our most dearly beloved Son Charles Philip Arthur George Prince of Wales Knight of Our Most Noble Order of the Gamer Our most dearly beloved Daughter Princess Anne Elizabeth Alice Louise Our most dear and entirely beloved Sister Princes Margaret Rose Countess of Snowdon Lady of the Imperial Order of the Crown of India Dame Grand Cross of Our Royal Victorian Order and Our most dear and entirely beloved Uncle and most faithful Counsellor Prince Henry William Frederick Albert Duke of Gloucester Knight of Our Most Noble Order of the Garter Knight of Our Most Ancient and Most Noble Order of the Thistle Knight of Our Most Illustrious Order of Saint Patrick Great Master and Principal Knight Grand Cross of Our Most Honourable Order of the Bath Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George Knight Grand Cross of Our Royal Victorian Order subject however to provisions enabling Us by the Letters Patent to except from among the number of those Counsellors any person who is absent from Our United Kingdom or intends to be so absent during the period of Our absence And Whereas Our Husband Prince Philip Duke of Edinburgh and Princess

Anne intend to accompany Us during Our absence from Our United Kingd m Know Ye that by virtue of the said enactments We do hereby delegate for the period of Our absence to the said Counsellors of State (excepting during their absence from Our United Kingdom those who intend to be so absent as hereinbefore recited) the Royal functions specified in the Fir t Schedule annexed hereto to be exerced join ly by not less t an two of their number subject to the following exceptions and conditions namely That they the said Counsell rs of State sh ll not have power to dissolve Parliament otherwise than on Our expres in tructions or to grant any rank title or dignity of the peerage That they shall not receive any homage required to be done to Ourself That they shall not approve or sign any warrant fiat ubmission or other document for which Our approval or signature is required for or in connection with any of the matters described in the Second Schedule annexed hereto and That if We signify or it appears to them that they sho ld not act in any matter or for any purpose without Our previous special approval they shall not act in that matter or for that purpo e without that approval Comm nding all and singular Archbishops Dukes Marquesses Earls Viscounts Bislop B ron Baronets Knights Citizens and Burgesses and all other Our Officers Ministers and Subjects that in everything appertaining to the matters aforesaid they be attendant counselling and helping the said Coun ellors of State as it behoves them In Witness whereof We have caused these Our Letters to be made patent Witne s Our elf at Westminster the thirteenth day of October in the twentieth year of Our Reign

PROPOSED 40 m.p.h. SPEED LIMIT TRUNK ROAD (ROUTE A.78) IN ARDROSSAN

THE TRUNK ROADS (VALE OF LEVEN)

(Prohibition of Waiting and Loading) Order 1971

Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
