THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 3(6) and 13 of the Import Duties Act 1958.

Viz.:—*The Import Duties (Temporary Exemptions) (No. 2) Order 1972*

This Order provides that the goods listed in Schedule 1 shall be temporarily exempt from import duty, and those listed in Schedule 2 shall continue to be exempt from import duty, both until 1st January 1973 or, in the case of certain items, until such earlier day as is specified.

As regards the exemption for equipment for use in aircraft under heading 85.15, apparatus of a type approved by the Secretary of State for Trade and Industry is listed in Civil Aviation Publication CAP 208, Airborne Radio Apparatus Vol. 2, published by Her Majesty's Stationery Office. (Restriction of Waiting) Order 1972*
