DRAFT SPECIAL REGULATIONS FACTORIES ACT 1961

IN pursuance of Section 180 of and Schedule 4 to the Factories Act 1961, the Secretary of State for Employment hereby gives notice that he proposes to make under Section 76 of the Act special regulations amending the Power Presses Regulations 1965. The regulations will require that the competent person carrying out an examination and test of a power press or a safety device under regulation 5 of the Power Presses Regulations 1965 shall, where the examination and test discloses certain defects which in the opinion of that person are or may become a cause of danger to employed persons, send within fourteen days to the factory inspector for the district a copy of the report of the examination and test.


