Temporary Closure of Trunk Road (Route A.702) Between its Junction with Route A.73 near Wandel and its Junction with Route B.7055 near Lamington

DISEASES OF ANIMALS ACT, 1950

The Diseases of Animals (Miscellaneous Fees) Order, 1972

NOTICE Is Hereby Given that the Minister of Agriculture, Fisheries and Food and the Secretary of State acting jointly have made the above-mentioned Order which came into operation on 1st July 1972.

This order consolidates with amendments the Diseases of Animals (Miscellaneous Fees) Order 1963, the Diseases of Animals (Miscellaneous Fees) Order 1964 and the Diseases of Animals (Miscellaneous Fees) Order 1970.

The order prescribes increased fees payable to the Minister of Agriculture, Fisheries and Food or to the Secretary of State for Scotland for business transacted under the Diseases of Animals Act 1950 with respect to—

- (i) the landing in Great Britain of certain cattle, sheep, goats and swine, and other animals imported for exceptional purposes (other than for exhibition);
- (ii) the landing in Great Britain, and the movement into Scotland from any other part of Great Britain of poultry and hatching eggs;
- (iii) the testing of disinfectants;
- (iv) the reception and isolation of animals in export quarantine stations provided by the Minister or the Secretary of State.

In addition, fees are for the first time prescribed for business transacted with respect to the landing in Great Britain of ruminating animals and swine, intended for exhibition.
