

NOTICE is hereby given that the Secretary of State for Scotland has made the following Orders under the Diseases of Animals Act 1950.

> The Brucellosis (Scotland) Order 1972 (1972 No. 1539 (S.118))

The Brucellosis Compensation (Scotland) Order 1972 (1972 No. 1538 (S.119))

The Brucellosis (Scotland) Order 1972 extends the compulsory slaughter powers in Section 17 of the Diseases of Animals Act to the slaughter of animals on account of brucellosis. These powers are required for full compulsory eradication which starts in certain areas of Scotland on 1st November 1972.

The order also provides for the service of statutory notices of intended slaughter on owners of reactors and dangerous contacts, and requires such owners to assist with the collection and penning of the animals to facilitate their identification, valuation and disposal.

The Brucellosis Compensation (Scotland) Order 1972 sets out the rates of compensation for animals slaughtered under the Brucellosis (Scotland) Order 1972.
