### TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 10th November 1972, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act, 1968, to the amount of £140,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, 13th November 1972 to Friday, the 17th November 1972, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

## WAGES COUNCILS ACT 1959

### *Rubber Proofed Garment Making Industry Wages Council*

### PROPOSED TEMPORARY CLOSURE OF TRUNK ROAD (ROUTE A.68) AT LEADERFOOT, ROXBURGHSHIRE

THE Secretary of State gives notice that he intends to make an order temporarily closing to traffic that part of trunk road (Route A.68) from its junction with Route B.6360 at Leaderfoot to its junction with Route B.6361 at Leaderfoot, Roxburghshire. The junction of Route B.6360 and Route A.68 will be closed completely and traffic requiring access to Route B.6360 from the trunk road will require to use the alternative route given below.

The road will be closed from 7 a.m. to 7 p.m. on two days between Sunday, 19th November and Sunday, 26th November 1972. Weather permitting the erection of a bridge over Route B.6360 will take place on 19th and 20th November, after which date the order will lapse; otherwise the road will be closed on the next two days when weather conditions are suitable.

*Alternative Route for Traffic*

Southbound traffic will leave the trunk road at its junction with the Leaderfoot-Smailholm Road and will proceed on that road in an easterly direction to its junction with Route B.6356, thence in a southerly direction on that road to its junction with Route B.6404. Vehicles will travel in a south-westerly direction in Route B.6404 to rejoin the trunk road at St. Boswells. Northbound traffic will travel in the reverse direction. Vehicles requiring access to Route B.6360 from the trunk road should travel on Route A.6091 from Newtown St. Boswells to its junction with Route B.6360.

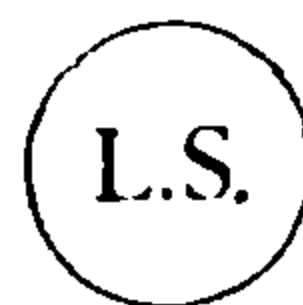

Under Section 9 of the Diseases of Animals Act 1950 (as amended by Section 105 of the Agriculture Act 1970) the Secretary of State for Scotland and the Minister of Agriculture, Fisheries and Food have power to vaccinate any animal which is in an infected area for the purposes of that Act.

This Order, which came into operation on 27th October to facilitate the exercise of such power in relation to foot-and-mouth disease, requires a person responsible for "relevant animals"—that is to say cattle, sheep, goats and all other ruminating animals and swine—in an area which is in an infected area under the Foot and Mouth Disease (Infected Areas Restrictions) Order of 1938, on being informed of the Ministers' proposal to vaccinate such animals, to submit them for vaccination against foot-and-mouth disease in accordance with the requirements of an authorised officer; and generally to render the latter such assistance as he may require to enable vaccination to be duly carried out.

A person on whom such a requirement is imposed must comply with the terms of any notice served on him at the time requiring him within 24 hours to state in writing for what other relevant animals within a radius of 10 miles he is also responsible.

## THE BRUCELLOSIS (SCOTLAND) ORDER 1972

THE BRUCELLOSIS COMPENSATION (SCOTLAND)  
ORDER 1972

NOTICE is hereby given that the Secretary of State has made the above-mentioned Orders, which come into operation on 1st November 1972.

The Brucellosis (Scotland) Order 1972, extends the compulsory slaughter powers in Section 17 of the Diseases of Animals Act to the slaughter of animals on account of brucellosis. These powers are required for full compulsory eradication, and apply with effect from 1st November 1972, to areas in Scotland which have been declared by Order to be Eradication Areas or Attested Areas. The Order also provides for the service of statutory notices of intended slaughter on owners of reactors and dangerous contacts, and requires such owners to assist with the collection and penning of the animals to facilitate their identification, valuation and disposal.

The Brucellosis Compensation (Scotland) Order 1972, sets out the rates of compensation for animals slaughtered under the Brucellosis (Scotland) Order 1972.

THE FOOT AND MOUTH DISEASE (INFECTED  
AREAS) VACCINATION ORDER 1972
