DEPARTMENT OF TRADE AND INDUSTRY THE PETROLEUM (PRODUCTION) **REGULATIONS 1966** THE PETROLEUM (PRODUCTION) (AMENDMENT) REGULATIONS 1972

THE Petroleum (Production) Regulations 1966 (S.I. 1966 No. 898) as amended by the Petroleum (Production) (Amendment) Regulations 1972 (S.I. 1972 No. 1522) provide, inter alia, for the grant by the Secretary of State for Trade and Industry of (i) exclusive exploration licences in respect of landward areas above the low water line and (ii) exclusive production licences in areas which lie on the landward side of lines drawn in accordance with the provisions of Schedule 1 to the Regulations.
