SPECIAL ROADS ACT 1949

ROADS (SCOTLAND) ACT 1970

THE ARLARY TO MUIRMONT SPECIAL ROAD

THE Secretary of State has made a scheme for a special road (motorway) commencing at the junction of the Inverkeithing-Perth Trunk Road (A.90) with the access road to Blairfield in the County of Kinross to Muirmont on the Inverkeithing-Perth Trunk Road (A.90) in the County of Perth. The scheme provides for the special road to become a trunk road, and that it will be for use only by motorway classes of traffic.

Other proposals will be published to carry existing roads or accesses over or under the special road or to stop them up. Access to the special road will be restricted to grade-separated junctions and it is at present planned that these should be located approximately at the sites shown circled on the plan.

Copies of the scheme, the title of which is the Arlary to Muirmont Special Road Scheme 1972 can be purchased through any bookseller or direct from Her Majesty's Stationery Office, 13a Castle Street, Edinburgh price 3p.

Copies of the scheme with plan have been deposited at the offices of the Scottish Development Department, 43 Jeffrey Street, Edinburgh, and Perth and Kinross Joint County Council, County Offices, York Place, Perth, and may be seen at all reasonable hours free of charge.

BELTS-SHERIFFSTON CROSSROADS SIDE ROADS ORDER

- 4. to provide that the initial charge for leaving a vehicle in any of the public parking places proposed to be established shall be five pence for an initial period of not more than one hour and ten pence for any period not exceeding two hours;
- 5. to provide that an excess charge of fifty pence shall become payable in respect of any vehicle left in a parking place for longer than the period for which payment was made by the initial charge;
- 6. to prescribe the manner in which vehicles shall stand in the parking places and to require that every part of a vehicle shall be within the limits of a parking bay;
- 7. to provide that a parking attendant may remove or arrange for the removal from a parking place of any vehicle in respect of which certain provisions of the Order have been contravened or not complied with;
- 8. to provide that severely disabled drivers or drivers of vehicles carrying severely disabled passengers may be exempted from the payment of parking charges;
- 9. to provide that a "no ticket" charge of £2 shall be incurred if any vehicle (other than a vehicle exempt from the parking charge) is left in a parking place without the initial charge having been paid;
- 10. to provide that the requirement to make payment of parking charges shall apply only in respect of the parking of vehicles between the hours of 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive; and
- 11. to make other incidental provisions.
