TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Thursday, the 19th April 1973, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, of the amount of £60,000,000.

dated and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payments in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

(2) below, be applicable to and have effect within the Controlled Area.
 - (2) The variations and exceptions referred to in para. (1) above are the following:—
 - (a) Articles 2, 3, 4, 5, 6, 7, 8 and 9, shall apply to pigs only;
 - (b) Article 10 shall apply only to a slaughterhouse which is, or at any time after 1st February 1973 has been, used for the slaughter of pigs;
 - (c) Article 14 shall not apply.

Saving for other Orders, Notices and Licences

3. Nothing in this Order shall in any way affect the operation of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 in regard to any area which is, for the time being, declared to be an Infected Area for the purpose of preventing the spread of swine vesicular disease or the operation of the restrictions imposed by any Notice served, or of the conditions of any Licence granted, under any Order of the Minister in respect of any premises or animals referred to in such Notice or Licence.
