TRUNK ROADS ACT 1946

- The Edinburgh-Stirling Trunk Road (North Broomage to Pirnhall Detrunking) Order 1973*
The Dennyloanhead-Kincardine Bridge Trunk Road (North Broomage to Bowtrees Detrunking) Order 1973

THE Secretary of State gives notice that he has made the above mentioned schemes and orders the effect of which will be to provide:—

1. Four schemes for the construction of special roads (motorways) for the exclusive use of traffic of Classes I and II set out in Schedule 2 to the Special Roads Act 1949 as varied by the Special Roads (Classes of Traffic) (Scotland) Order 1971:—
 - (a) from Longdyke to Pirnhall,
 - (b) from North Broomage to Hill of Kinnaird and from Kinnaird House to Bowtrees,
 - (c) to connect the Longdyke to Pirnhall Special Road to the Glasgow-Stirling Trunk Road (A.80/M.80) at Pirnhall Roundabout and to the Kinnaird House to Bowtrees Special Road at Longdyke, and
 - (d) to connect the Dennyloanhead to North Broomage Special Road as already established to the Edinburgh-Stirling Trunk Road (A.9) and the Dennyloanhead-Kincardine Bridge Trunk Road (A.876) at North Broomage,

all in the County of Stirling.

2. Two orders for
 - (a) (i) the improvement, raising, lowering or otherwise altering roads,
 - (ii) stopping up roads and constructing new roads, and
 - (iii) stopping up private means of access to premises and providing new means of access,

all on or in the vicinity of the routes of the Longdyke to Pirnhall Special Road and the North Broomage to Hill of Kinnaird and Kinnaird House to Bowtrees Special Roads, and providing

- (b) that the County Council of the County of Stirling shall become the highway authority for the new roads.

3. Two orders for:—
 - (a) the detrunking of those lengths of the Edinburgh-Stirling Trunk Road (A.9) and the Glasgow-Stirling Trunk Road (A.80) from the roundabout at North Broomage to the roundabout near Bannockburn and to the roundabout at Pirnhall, and
 - (b) the detrunking of that length of the Dennyloanhead-Kincardine Bridge Trunk Road (A.876) between the roundabout at North Broomage and the roundabout at Bowtrees,

which the Longdyke to Pirnhall Special Road and the North Broomage to Hill of Kinnaird and Kinnaird House to Bowtrees Special Roads are designed to replace.

Copies of the schemes and orders and of the plans referred to therein have been deposited at the offices of the Scottish Development Department, 43 Jeffrey Street, Edinburgh and the County Council of the County of Stirling, County Offices, Viewforth, Stirling.

Any person aggrieved by the schemes and orders desiring to question the validity thereof, or of any provision contained therein, on the grounds that they are not within the powers of the Special Roads Act 1949 or the Trunk Roads Act 1946, as applicable, or that any requirement of the said Acts or of regulations made thereunder, has not been complied with in relation to the schemes and orders may, within six weeks of 16th November 1973, apply to the Court of Session for the suspension or quashing of the schemes and orders or of any provision contained therein.

PRIVATE LEGISLATION PROCEDURE (SCOTLAND) ACT 1936

NOTICE is hereby given in terms of Section 1(4) of the Private Legislation Procedure (Scotland) Act 1936 that the Secretary of State, the Chairman of Committees of the House of Lords and the Chairman of Ways and Means in the House of Commons having considered representations by the Clerical, Medical and General Life Assurance Society that it is expedient that the under-mentioned Parliamentary powers to be operative in Scotland and elsewhere which the Society desire to obtain should be conferred by one enactment have decided that the said powers would more properly be obtained by the promotion of a Private Bill than by the promotion of a Private Bill and of a Provisional Order under the said Act.

To incorporate the Clerical, Medical and General Life Assurance Society. To provide for the transfer to the incorporated Society of the property and assets of the existing Society, for the continuance by the incorporated Society of the business and undertaking of the existing Society, for the saving of contracts and actions, for the existing directors, auditors and staff to continue in office and for other matters incidental and supplementary to the incorporation of the Society. To repeal the Clerical, Medical and General Life Assurance Acts of 1850 and 1887 and some of the provisions of the Clerical, Medical and General Life Assurance Act 1961. To amend the Laws and Regulations applying to the existing Society and to apply the amended Laws and Regulations to the incorporated Society.
