It is this day ordered by their Lordships, that the reading the form of prayer to Almighty God, which was prepared by his Grace the Archbishop of Canterbury, in pursuance of the order of this board, dated 5th November 1810, for the restoration of his Majesty's health, bed discontinued. discontinued; and that his Grace the Lord Archbishop of Canterbury do prepare a new form of prayer, to be used in lieu thereof.

And it is hereby further ordered, that his Majesty's printer do forthwith print a competent number of copies of the said form of prayer, that the same may be forthwith sent round, and read in the several churches throughout those parts of the United Kingdom called England and Ireland. JAS. BULLER.

WESTMINSTER-FEBRUARY 4, 1812.

This day the Lords being met, a message was sent to the Honourable House of Commons by the Yeoman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of a Commission under the Great Seal, signed by the Prince Regent, in the name and on the bebalf of his Majesty, for declaring his Majesty's Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers, to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An act for continuing to his Majesty certain duties on malt, sugar, tobacco, and snuff, in Great Britain, and on pensions, offices, and personal estates in England, for the service of the year 1812.

An act to permit sugar, the produce of Martinique and other conquered islands in the West Indies, to be taken out of warehouse, on the payment of the like rate of duty for waste as British plantation sugar.

An act for raising the sum of ten millions five hundred thousand pounds by Exchequer bills, for the service of Great Britain for the year 1812.

An act for raising the sum of one million five hundred thousand pounds, by Exchequer bills, for the service of Great Britain for the year 1812.

An act to revive and continue until the 31st day of December 1812, so much of an act made in the 49th year of his present Majesty, to prohibit the distillation of spirits from corn or grain in the United Kingdom, as relates to Great Britain; and to revive and continue another act, made in the 49th year aforesaid, to suspend the importation of British or Irish made spirits into Great Britain or Ireland respectively; and for granting certain duties on worts or wash made from sugar, during the prohibition of distillation from corn or grain in Great Britain.
