THE CAPITAL GAINS TAX

*The Capital Gains Tax (Exempt Gilt-Edged Securities)
Order 1974*

IN accordance with section 41(2) of the Finance Act 1969 the Treasury give notice that an Order entitled The Capital Gains Tax (Exempt Gilt-Edged Securities) Order 1974 has been made under the provisions of that Act and Section.

This Order adds the following gilt-edged security to the category of stocks and bonds which are exempt from tax on capital gains if held for more than 12 months:—

12% Treasury Loan 1983

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 1, 3(6) and 13 of the Import Duties Act 1958 as amended viz.:—
The Import Duties (Temporary Reductions and Exemptions) (No. 5) Order 1974.

This Order provides for exemption from or reductions in import duty in the case of goods specified in the Schedule to the Order from 20th April 1974 until 31st December 1974 or any earlier date appearing in the Schedule.

There is exemption from import duties in the case of all goods in the Schedule if the goods satisfy the requisite conditions to benefit from the eventual abolition of customs duties in trade between member States of the European Communities.

In the case of other goods, where a rate of duty is specified in column 3 of the Schedule, duty is reduced to that rate, instead of any higher rate which would otherwise apply, and where "free" appears in column 3 in relation to the goods, they are exempt from duty.

In the case of goods originating in Egypt or Cyprus greater reductions in duty are available in a number of cases than those referred to above. These are shown respectively in columns 4 and 5 of the Schedule.

The Order comes into operation on 20th April 1974 and has been published as Statutory Instrument 1974 No. 682.

BURGH OF PAISLEY

The Burgh of Paisley (Bus Stops) (Clearway) Order 1974

1. ON 9th April 1974, Paisley Town Council made an Order under Section 1(1), (2), (3), (3B) and (6) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, prohibiting vehicles, other than buses from waiting at any time on any day at any bus stop in any of the roads specified below where the carriageway at that stop is marked (a) as a bus stop, and (b) with a broad yellow line adjacent to the edge of the carriageway ("the authorised markings"):

- (a) Broomlands Street
- (b) Causeyside Street
- (c) Gauze Street
- (d) Gilmour Street
- (e) Glasgow Road
- (f) High Street
- (g) Moss Street
- (h) Neilston Road
- (j) Old Sneddon Street
- (k) Renfrew Road
- (l) Smithhills Street
- (m) Well Street

2. Although the Order includes every bus stop in the roads specified above, it should be noted that the provisions of the Order which prohibit waiting apply only to those stops which the Council marks with the authorised markings.

3. While the Order remains in force the Council would be able at any time to lay or to remove the authorised marking at or from any bus stop in a specified road or to adjust the position in that road of the authorised markings, as traffic conditions may require.

4. Other vehicles will be permitted to wait at bus stops with authorised markings, where necessary, for

1. the removal of an obstruction to traffic
2. the maintenance of the road and in exercise of statutory powers with permission of the Council, and
3. reasons of emergency.

5. A copy of the Order and Map showing the routes affected are available at the Municipal Buildings, Paisley, where they may be examined between 9 a.m. and 5.30 p.m. Mondays to Fridays.

6. Any person who wishes to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order may, within 6 weeks from the 9th April 1974, apply to the Court of Session for this purpose.
