

None:-Imports of uncooked meat and meat products from certain countries are restricted, and in some cases prohibited, on animal health grounds by the Importation of Carcases and Animal Products Order 1972.

## PROPOSED PROHIBITION AND WAITING **RESTRICTION ORDER**

1. THE Town Council of the Burgh of Bathgate propose to make an Order under Section 9 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

#### BURGH OF DUNBLANE

#### RESTRICTIONS ON WAITING (RAMOYLE) **ORDER** 1974

THE Dunblane Town Council propose to make an Order under Section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit vehicles from waiting at any time or during limited periods on the length of road described in the Schedules hereto.

Exceptions will permit waiting for the purposes of (a) picking up and setting down passengers, (b) loading and unloading gods, where necessary in connection with (c) the maintenance of the road and, (d) the supply of gas, electricity, and water, and by (e) disabled drivers.


