TRUNK ROADS ACT 1946 THE EDINBURGH - CARLISLE TRUNK ROAD (CHANNEL STREET AND MARKET STREET, GALASHIELS) (TRUNKING) ORDER 1975

THE Secretary of State proposes to make an order under which Channel Street and, part of Market Street, Galashiels will become part of the Edinburgh - Carlisle Trunk Road. This results from the introduction of a one way traffic system on part of the existing trunk road in Galashiels, and will transfer responsibility for routes used by both north and south bound through traffic, to the Secretary of State.

Recall of Sequestration

HUMBLY SHEWETH:

1. That on 28th January 1975 on the application of Mrs Margo Trainer or Anderson, 44 Rowan Drive, Clydebank, the estates of the Petitioner were sequestrated by Deliverance of the

Sheriff of the Lothians and Peebles at Edinburgh. The Petitioner did not consent to the said application. A copy of the said Application and of the relative Deliverance thereon will be produced.

- 2. That on 4th October 1974 the Petitioner was divorced by the said Mrs Margo Trainer or Anderson and the said Mrs Anderson was granted a capital sum of £2,700, which had in fact been agreed by the parties prior to the said Interlocutor granting divorce. In order that the Petitioner could pay the capital sum which had been granted it was necessary for him to sell the flat in which he lived. There was some small delay in the sale of the flat in view of the state of the market but by the time the proceedings for sequestration called in Court on 14th January 1975 the capital sum of £2,700 with interest thereon from the date of the decree of divorce had been paid by the Petitioner to the said Mrs Anderson. Agents acting for the Petitioner informed the Agents acting for the said Mrs Anderson that they had retained out of the purchase price of the said flat sufficient funds to cover the expenses of the divorce action and the sequestration proceedings.
- 3. That on 14th January 1974 the said sequestration proceedings called in Court and were then continued for two weeks to enable the expenses of the divorce action and of the sequestration proceedings to be paid by the Petitioner. This was not in fact done by 28th January 1975 in view of the fact that Agents for the Petitioner were checking the account which had been given to them by the Agents for the said Mrs Anderson. The Agents for the Petitioner wrongly overlooked the fact that the sequestration proceedings called in Court again on 28th January 1975 when despite the aforesaid history of the case sequestration was granted. The creditors were appointed to hold a meeting on 6th February 1975 to elect a trustee, but no meeting took place and no trustee was elected.
- 4. The Petitioner has paid the expenses both of the divorce action and of sequestration proceedings. There are no known creditors of the Petitioner.
- 5. In these circumstances the Petitioner now makes application to Your Lordships for recall of the said award of sequestration. This application is made in terms of Section 30 of the Bankruptcy (Scotland) Act 1913.

MAY it therefore please your Lordships to appoint this Petition to be intimated on the Walls and in the Minute Book in common form and to be served upon the person named and designed in the Schedule hereto and to appoint a notice of the presentation of this Petition to be published in the Edinburgh Gazette and to ordain all parties claiming interest to lodge Answers hereto if so advised within fourteen days after such intimation, service and advertisement; and thereafter upon resuming consideration hereof, with or without Answers to recall the said Award of Sequestration dated 28th January 1975 and to appoint the Interlocutor recalling the same to be entered in the Register of Sequestration and an abreviate extract of that Interlocutor to be recorded in the Register of Inhibitions and Adjudications, and to find the Petitioner entitled to the expenses of and incidental to this application against any person or persons appearing to oppose the Prayer hereof; and to decern; or to do further or otherwise in the premises as to your Lordships shall seem proper.
