GENERAL WASTE MATERIALS RECLAMATION
WAGES COUNCIL (GREAT BRITAIN)

THE General Waste Materials Reclamation Wages Council (Great Britain) hereby gives notice of its intention to submit to the Secretary of State for Employment proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (General Waste Materials Reclamation) Order 1974 (Order D.B.(81)) as amended by the Wages Regulation (General Waste Materials Reclamation) (Amendment) Order 1975 (Order D.B.(85)); (2) amending the provisions relating to holidays and holiday remuneration set out in the Wages Regulation (General Waste Materials Reclamation) (Holidays) Order 1973 (Order D.B.(79)) as amended by the Wages Regulation (General Waste Materials Reclamation) Order 1974 (Order D.B.(81)); and (3) the revocation of Orders D.B.(81), D.B.(85) and D.B.(79).
