NOTICE OF SUBMISSION OF PRELIMINARY DRAFT
REGULATIONS ENTITLED THE SOCIAL SECURITY
(CONTRIBUTION) AMENDMENT REGULATIONS 1976**

IN accordance with Section 139 of the Social Security Act 1975, the National Insurance Advisory Committee give notice that they have received for consideration and report thereon the preliminary draft of regulations entitled the Social Security (Contribution) Amendment Regulations 1976.

A short explanatory note on these regulations is appended to this notice. The Committee will take into consideration any objections made by or on behalf of persons affected, received by them not later than 23rd December 1975. Objections should be addressed to the Secretary, National Insurance Advisory Committee, Keysign House, 429 Oxford Street, London W1R 2HT. Copies of the preliminary draft of these regulations can be obtained by sending a stamped and addressed foolscap envelope to the Secretary of the National Insurance Advisory Committee.

EXPLANATORY NOTE

These regulations amend the Social Security (Contribution) Regulations 1975 ("the principal Regulations").

They make provision for paragraph 3(1) of Schedule 1 to the Social Security Act 1975 (liability in the first instance of secondary contributor to pay primary class I contributions) not to apply in respect of earnings from any employed earner's employment where by virtue of an arrangement under regulation 41 of the principal Regulations the earner has agreed himself to pay any primary Class I Contributions payable in respect of these earnings. They also make provision in such a case for the earner to be excepted from liability to pay these contributions if he has paid in respect of his earnings from

an employment which is not subject to the arrangement an amount equal to 52 primary class I contributions at the rate applicable to him on earnings at the upper earnings limit. They further make provision for contributions paid in accordance with the arrangement to be treated as paid on the due date.

The Regulations also provide for payments by way of pensions to be disregarded in the calculation of earnings; and for a self-employed earner to be excepted from liability for class 2 contributions in any week in which he is in receipt of invalid care allowance.

The regulations also extend the provisions of regulation 25 of the principal Regulations (class 3 not paid within prescribed periods) to class 3 contributions payable for periods abroad.

The other amendments are of a minor nature.

EXPLANATORY NOTE

The Regulations provide for the manner in which evidence of incapacity for work or of expected confinement or confinement is to be given for the purposes of a claim for benefit under the Social Security Act 1975 for which such proof is required. The Regulations replace the Social Security (Medical Certification) Regulations 1975 ("the 1975 Regulations") which are revoked.

The Regulations and Rules in Schedule 1 prescribe a certificate in the form of a doctor's statement in which the issuing doctor advises the claimant that he need not refrain from work or, as the case may be, that he should refrain from work for a period of up to 6 months, or longer in certain circumstances. Certificates for the purposes of maternity benefit are prescribed in Schedule 2 and correspond to those in the 1975 Regulations. The Regulations amend the Social Security (Claims and Payments) Regulations 1975 so that doctor's statements and doctor's statements in the form of special statements based on a written report from another doctor may be accepted for the purposes of forward allowances of certain benefits.
