

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.





(PROHIBITION OF WAITING AND LOADING)

TRUNK ROADS ACT 1946 ROADS (SCOTLAND) ACT 1970 THE GLASGOW-GREENOCK TRUNK ROAD (INCHINNAN OPENING BRIDGE) ORDER 1975

THE Secretary of State has made an Order providing for the Inchinnan Opening Bridge over the Rover White Cart at Inchinnan, in the District of Renfrew in Strathclyde Region, to become trunk road.
