THE following Address has been present-to his Royal Highness the Prince Regent; which Address his Royal Highness was pleased receive very graciously .-

To his Royal Highness the Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

The humble and dutiful Address of the Gentlemen, Freeholders, Justices of the Peace, Commissioners of Supply, and Heritors of the County of Roxburgh, convened at the Anniversary Meeting, held here this day.

May it please your Royal Highness,

WE, the Gentlemen, Freeholders, Justices of the Peace, Commissioners of Supply, and Heritors of the county of Roxburgh, humbly beg leave to approach your Royal Highness, with feelings of strong attachment to your person and government.

We deeply lament the indisposition of our much beloved Sovereign, and earnestly pray for

his recovery. We numbly condole with your Royal Highnese, and beg leave to express our horror and detestation at the late atrocious murder of the Right Honourable Spencer Perceval, Chancellor of the Exchequer, the integrity of whose public character; and exemplary virtues in private life, had combined to excite the confidence of the country in his administration of your Royal Highness's government. But while we deplore these melancholy events, we feel much comfort and consolation in the wisdom and firmness with which the weighty and important affairs of the empire have, and we fondly hope and trust will continue to be conducted, by your Royal Highness and his Majesty's ministers.

Wehumbly beg leave to congratulate your Royal Highness on the late brilliant successes of his Majesty's fleets and armies; and we offer our earnest wishes for a continuance of them during the present arduous struggle in which the country is engaged. And we conclude with again assuring your Royal Highness of our steady loyalty

and attachment, and of our firm determination to maintain and support the crown and dignity of the realm, to the utmost of our power; and that the life of your Royal Highness may be long preserved, and the result of your councils may ever tend to the honour, glory, and prosperity of the empire, is our most fervent wish and earnest prayer.

At the Court at Carlton-House, June 17, 1812. His Royal Highness the Prince Regent, acting in the name and on the behalf of Majesty, Sovereign of the most Honourable Military Order of the Bath, has been pleased, by an especial warrant under the sign-manual of his Royal Highness and the seal of the said Order, to dispense with all the statutes and regulations usually observed in regard to Installation; and to give and grant unto Lieutenant-General the Honourable Sir Edward Paget, an Extra Knight of the said most Honourable Military Order, full power and authority to exercise all rights and privileges belonging to a Knight Compa-nion of the most Honourable Military Order of the Bath, as if he had been formally installed; any decree, rule, or usage to the contrary notwithstanding.

WHITEHALL JUNE 20, 1812.

His Royal Highness the Prince Regent has been pleased, in the name and on the behalf of his Majesty, to order a Congé d'Elire to pass the Great Seal of the United Kingdom of Great Britain and Ireland, empowering the Dean and Chapter of the Cathedral Church of Cliester to elect a Bishop of that See, the same being yold by the translation of the Right Reverend Father in God Edward, late Bishop thereof, to the See of Ely; and his Royal Highness has also been pleased, by his royal sign-manual, to re-

commend to the said Dean and Chapter, the Reverend George Henry Law, Doctor in Divinity, to be by them elected bishop of the said See of Chester.
