THE SOCIAL SECURITY  
(INVALID CARE ALLOWANCE)  
REGULATIONS 1976

IN accordance with Section 139 of the Social Security Act 1975, the National Insurance Advisory Committee give notice that they have received for consideration and report thereon the preliminary draft of regulations entitled The Social Security (Invalid Care Allowance) Regulations 1976.

A short explanatory notice on these regulations is appended to this notice.

The Committee will take into consideration any objections, made by or on behalf of persons affected, received by them not later than 20th February 1976. Objections should be addressed to the Secretary, National Insurance Advisory Committee, Key-sign House, 429 Oxford Street, London W1R 2HT.

EXPLANATORY NOTE

The draft regulations complete the entitlement conditions for Invalid Care Allowance, the legislative framework having been laid down in the Social Security Act 1975. This is a new benefit for people who care for severely disabled relatives and it is planned to be introduced during 1976/77.

A severely disabled person is defined by the 1975 Act as a person for whom an attendance allowance is payable. The draft regulations extend this definition and also prescribe the amount of care required to qualify for Invalid Care Allowance.

The draft regulations list a wide range of relatives the care of whom may confer entitlement to the allowance and they prescribe the circumstances in which increases may be paid for child or adult dependants. The conditions relating to residence and presence in Great Britain are set out together with other provisions of a technical nature.

WAGES COUNCILS ACT 1959  
REFERENCE TO THE ADVISORY, CONCILIATION  
AND ARBITRATION SERVICE

THE Secretary of State for Employment, early in 1975, received from the Transport and General Workers Union and the United Road Transport Union, an application under Section 5(1)(c) of the Wages Councils Act 1959, as inserted by paragraph 9(3) of Schedule 3 to the Trade Union and Labour Relations Act 1974 for the abolition of the Road Haulage Wages Council. The Unions represent a substantial proportion of workers with respect to whom the Council operates and made their application on the ground that the Council is no longer necessary for the purpose of maintaining a reasonable standard of remuneration for the workers with respect to whom the Council operates.

The Secretary of State, in accordance with statutory requirements has consulted the Wages Council and all such organisations of employers as in his opinion represent a substantial proportion of employers with respect to whom the Council operates. In the light of these consultations the Secretary of State has decided not to proceed forthwith with the making of an order giving effect to the Unions' application.

The Secretary of State in accordance with Section 6(1)(a) of the 1959 Act, as amended by the Employment Protection Act 1975, has referred to the Advisory, Conciliation and Arbitration Service for investigation and report the question whether the said Wages Council should be abolished.

(RESTRICTION OF WAITING) ORDER 1976
