WAGES COUNCILS ACT 1959 EMPLOYMENT PROTECTION ACT 1975 DRESSMAKING AND WOMEN'S LIGHT OLOTHING WAGES COUNCIL (SCOTLAND)

THE Dressmaking and Women's Light Clothing Wages Council (Scotland) hereby gives notice of proposals for (1) varying the statutory minimum remuneration as set out in the Wages Regulation (Dressmaking and Women's Light Clothing) (Scotland) (No. 2) Order 1975 (Order WDS(111)); amending the provisions relating to holidays and holiday remuneration as set out in the Wages Regulation (Dressmaking and Women's Light Clothing) (Scotland) (Holidays) (No. 2) Order 1974 (Order WDS(109); and (3) the revocation of Order WDS(111) and Order WDS(109). The Wages Council intends that the revised provisions shall come into operation on 30th June 1976. Particulars of the proposals are contained in the Wages Council's Notice (WDS(112) copies of which may be obtained on application to the Secretary of the Wages Council at the address given below. The Wages Council will consider any written representation with respect to the proposals if made within 14 days from 13th July 1976. 


