# TENDERS FOR TREASURY BILLS

- 1. DISEASES OF ANIMALS ACT 1950

NOTICE is hereby given in pursuance of Section 85(3) of the Diseases of Animals Act 1950 that the Minister of Agriculture, Fisheries and Food and the Secretary of State for Scotland, acting jointly, have made the following Order:—

### STATUTORY INSTRUMENTS 1976 No. 2101 DESIGNATION OF LOCAL AUTHORITY (HEATHROW AIRPORT — LONDON) ORDER 1976 (MADE 8th DECEMBER 1976)

This Order which came into operation on the 29th December 1976 makes the Corporation of London the local authority for the purposes of the provisions of the Diseases of Animals Act 1950 (as extended and amended) which relate to imported animals in respect of that part of Heathrow Airport which lies within the County of Surrey, and accordingly the Corporation of London is now the local authority responsible in respect of the whole of Heathrow Airport for the enforcement of the Act in its relation to imported animals and so far as the Act is to be enforced by a local authority.

### STATUTORY INSTRUMENTS 1976 No. 2195 THE RABIES (COMPENSATION) ORDER 1976 (MADE 21st DECEMBER 1976)

Under the Rabies (Control) Order 1974, the Minister of Agriculture, Fisheries and Food is given power to slaughter any animal to which that order applies which is affected with or suspected of being affected with rabies, or which has been exposed to the infection of that disease. The present order which came into operation on the 27th January 1977 fixes the amount of compensation payable in respect of a slaughtered animal, and provides that, in the case of an animal affected with rabies at the time of its slaughter, compensation shall be payable at the rate of 50 per cent of the market value of the animal immediately before it contracted the disease. In all other cases, the compensation will consist of the full market value of the animal immediately before slaughter.
