ROAD TRAFFIC REGULATION ACT 1967

THE PRESTWICK AIRPORT (TEVIOT ROAD) (15 m.p.h. SPEED LIMIT) ORDER 1977

- ON 18th November 1977, The British Airports Authority, with the consent of the Secretary of State, made the above-named Order under Section 74(1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968.
- This Order, which makes it unlawful to drive motor vehicles at a speed exceeding 15 m.p.h. on that length of Teviot Road within Prestwick Airport from the junction with Teviot Square in an easterly direction for a distance of approximately 350 metres to the eastern boundary of the property known as "the Bower", shall come into operation on 1st December 1977.
- A copy of the Order and a map showing the road affected are available for inspection at the office of the Traffic & Commercial Manager, Prestwick Airport, between the hours of 9.30 a.m. and 4.00 p.m. Monday to Friday inclusive.
- Any person who wishes to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, may, within 6 weeks from 18th November 1977, apply to the Court of Session for this purpose.
