ROAD TRAFFIC REGULATION ACT 1967 THE GLASGOW AIRPORT TRAFFIC REGULATION ORDER 1978

ON 18th January 1978, The British Airports Authority made the above named Order under Section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

This Order, which comes into operation on 13th March 1978, imposes restrictions on certain roads within Glasgow Airport:—
