EXPLANATORY NOTE

These Regulations further amend regulation 12 of the Social Security (Overlapping Benefits) Regulations 1975 as substituted by regulation 10(5) of the Social Security (Child Benefit Consequential) Regulations 1977 and amended by the Social Security (Miscellaneous Amendments) Regulations 1978 so as to provide that where more than one person is emitted to receive an increase of benefit in respect of the same child, priority of entitlement among those persons claiming such an increase shall be given first to a person to whom Child Benefit has been awarded in respect of the child for the period for which the increase is claimed.

- 3. Nothing in the proposed Order shall make it unlawful for a Heavy Commercial Vehicle transporting timber from the Ae Forest to the A74 to proceed along that part of Route reference 2 specified in the Schedule above between Millhousebridge and the A74.
- Nothing in the proposed Order shall make it unlawful for a Heavy Commercial Vehicle to proceed on any of the above lengths of road if the vehicle is being used:—
