PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975 NOTICE OF APPLICATION FOR A SUBMARINE PIPE-LINE WORKS AUTHORISATION

CONOCO NORTH SEA INC. hereby gives notice on behalf of itself and BNOC (Exploration) Ltd. and Gulf Oil Corporation, in accordance with the provisions of Part I of Schedule 4 to the Petroleum and Submarine Pipe-lines Act 1975, that it has made an application to the Secretary of State of Energy for the grant of an authorisation for the constituction and use of submarine flowline bundles for the conveyance of oil to the Murchison Platform from Murchison Satellite Wells Numbers 211/19-2 and 211/19-4, and for the conveyance of water to Murchison Satellite Well Number 211/19-3 from the Murchison Platform.
