His Royal Highness the Prince Regent has been graciously pleased, in the name and on the behalf of his Majesty, to constitute and appoint William Horne, Esq. Advocate, to be Sheriff-Depute of the shire of Haddington, in the room of Alexander Maconochie, Esq. appointed Solicitor-General in Scotland.

### WESTMINSTER-APRIL 15, 1813.

This day the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of a Commission under the Great Seal, signed by the Prince Regent, in the name and on the behalf of his Majesty, for declaring bis Majesty's Royal Assent to several Acts agreed upon by both Houses, do destre the immediate attendance of the Honourable House in the House of Peers, to bear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to
