## (ROUTE A80) (STRATHCLYDE REGION) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 1980

#### EXPLANATORY NOTE

These regulations further amend the Social Security (Contributions) Regulations 1979 ("the principal regulations").

They provide that payments to an employed earner derived from service charges relating to the provision of meals, drink or accommodation shall be disregarded from the purposes of earnings-related contributions when not allowed directly or indirectly by the secondary contributor.

They also extend the provisions of the principal regulations so as to enable persons to whom allowances are payable under the Job Release Act 1977 to pay Class 3 contributions up to six years after the year in which the allowance ceased to be payable. They provide that for the purposes of entitlement to contributory benefits such contributions shall be treated as duly paid.

They also prescribe a new list of establishments and organisations of which, for the purposes of the Social Security Act 1975, Her Majesty's Forces are taken to consist.

The other amendments are minor or consequential.

They add new provisions which disregard for contributions purposes employment as a military or civilian member of a Visiting Force except where the civilian is ordinarily resident in the United Kingdom, and employment as a member of an Headquarters designated under section 1 of the International Headquarters and Defence Organisations Act 1964 except where the member is a serving member of Her Majesty's forces raised in the United Kingdom or an officer of the Brigade of Gurkhas who is not a Queen's Gurkha officer.
