MEDICINES ACT 1968

AMENDMENTS TO THE EUROPEAN PHARMACOPOEIA

ON behalf of the Health Ministers, that is to say the Secretaries of State respectively concerned with Health in England, in Wales and in Scotland, and on behalf of the Department of Health and Social Services for Northern Ireland, it is hereby declared under Section 65(8) of the Medicines Act 1968 that the Amendments to the European Pharmacopoeia set out in the Schedule hereto, which were adopted by the European Pharmacopoeia Commission on 30th June 1981 and published in accordance with the Convention on the Elaboration of a European Pharmacopoeia, are to have effect for the purposes of the said Section 65 on 1st October 1981.

SCHEDULE

Supplement to Volume II

Aqua ad Iniectabilia (Water for Injections)

Page 33. Modified tests to be applied to Water for Injection after sterilisation. Add the following:—

"Chlorides (Vol I, page 107) For containers with a nominal volume of 10 ml or less, 15 ml complies with the limit test for chlorides (0.5 ppm). Prepare the standard using a mixture of 1.5 ml of chloride standard solution (5 ppm Cl) R and 13.5 ml of water."

Volume III

Acidum Tartaricum (Tartaric Acid)

Page 137. Specific optical rotation. Replace the text by the following:—

"Specific optical rotation (Vol I, page 80) Dissolve 4.00 g in water and dilute to 20.0 ml with the same solvent. The specific optical rotation is between $+11.9^{\circ}$ and $+12.7^{\circ}$."

Vaccinum Diphthericum Adsorbatum (Diphtheria Vaccine (Adsorbed))

Determination of potency In the ninth line from the foot of page 167 and in the first line of page 169, replace "a series differing by 2.5-fold steps" by "a series differing by not more than 2.5-fold steps".

Vaccinum Tetanicum Adsorbatum (Tetanus Vaccine (Adsorbed))

Determination of potency In the seventeenth line from the foot of page 176 and in the fifth line from the foot of page 177, replace "a series differing by 2.5-fold steps" by "a series differing by not more than 2.5-fold steps".

THE GRETNA-STRANRAER-GLASGOW-STIRLING TRUNK ROAD (CARSLUITH DIVERSION) COMPULSORY PURCHASE ORDER 1981

NOTICE is hereby given that the Secretary of State in exercise of the powers conferred on him by the above mentioned Acts, on the 6th day of July 1981 made a Compulsory Purchase Order entitled The Gretna-Stranraer-Glasgow-Stirling Trunk Road (Carsluith Diversion) Compulsory Purchase Order 1981, authorising him to purchase compulsorily the land in the Parish of Kirkmabreck in the Dumfries and Galloway Region described in the Schedule hereto for the purposes of constructing a new length of the Gretna-Stranraer-Glasgow-Stirling Trunk Road (A75).

A copy of the Order as made and of the map referred to therein have been deposited at the offices of the Scottish Develoment Department, New St. Andrew's House, Edinburgh; the Dumfries and Galloway Regional Council, Council Offices, Dumfries and at the Post Office, Creetown, Newton Stewart and may be inspected free of charge at all reasonable hours from 24th July 1981 to 4th September 1981.

The Order as made becomes operative on the 24th July 1981, being the date on which this notice is first published; but a person aggrieved by the Order may, in accordance with the provisions of paragraph 15 of the First Schedule to the Acquisition of Land (Authorisation Procedure) (Scotland) Act 1947 as extended by Section 60 of the Land Compensation (Scotland) Act 1973, by application to the Court of Session within 6 weeks from that date, question its validity on the grounds (i) that the authorisation granted by the Order is not empowered to be granted, or (ii) that his interests have been substantially prejudiced by failure to comply with any statutory requirement relating to the Order.

The Secretary of State may acquire the land and the rights in land to which this Notice relates by making a General Vesting Declaration under Section 278 of the Town and Country Planning (Scotland) Act 1972. Such a declaration shall not be executed before the end of the period of two months beginning with the date of the first publication of this notice except with the consent of every occupier of the land affected. The effect of the making of such a Declaration is to vest the land and the rights in the Secretary of State at the end of the appropriate period and is more fully explained in Form 9 contained in The Compulsory Purchase of Land (Scotland) Regulations 1976 (SI 1976 No. 820). A copy of the said Regulations has also been deposited and may be seen as aforesaid.

THE TRUNK ROADS (ROUTE M8/M898) (ARKLESTON BRIDGE TO ERSKINE BRIDGE) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 1981

THE Secretary of State gives notice that he has made the above Order temporarily prohibiting the driving of vehicles on any part or parts of the undermentioned lengths of road; being lengths of the Glasgow-Greenock-Monkton Trunk Road (Route M8) and the Craigton Interchange-Dalnotter Interchange Trunk Road (Route M898) in Strathclyde Region, whilst temporary road works, indicated by appropriate traffic signs are in progress.

- (a) That length of the Glasgow-Greenock-Monkton Trunk Road (M8), in Strathclyde Region as measured from the centre line of the road bridge carrying Arkleston Road over the said trunk road westwards and then generally northwards to its junction with and thereafter along that length of special road at Craigton Interchange, (being the junction of the said M8 trunk road and the Craigton Interchange-Dalnotter Interchange Trunk Road (M898)), forming the slip road connecting the northbound carriageway of the M8 trunk road with the northeastbound carriageway of the M898 trunk road as far as the north side of the road bridge carrying Old Greenock Road (C22) over the M898 trunk road, a distance of 9.3 kilometres or thereby.
- (b) That length of the Craigton Interchange-Dalnotter Interchange Trunk Road (M898) as measured from the north side of the road bridge carrying Old Greenock Road (C22) over the M898 trunk road generally northwards to its junction with and thereafter along that length of special road forming the link road between the northeastbound carriageway of the M898 trunk road and the slip road to the westbound carriageway of the Bishopton-Erskine Bridge as far as a point on that slip road 270 metres or thereby south of the centre of the roundabout at the junction of the said slip road (M898), the Paisley-Erskine Bridge Road (A726) and the Bishopton-Erskine Bridge Road (B815), a distance of 1.2 kilometres or thereby.
- (c) That length of special road at the Craigton Interchange forming the slip road connecting the southwestbound carriageway of the M898 trunk road with the northbound carriageway of the M8 trunk road as measured from the north side of the road bridge carrying Old Greenock Road (C22) over the M898 trunk road as far as its junction with the M8 trunk road, a distance of 720 metres or thereby.

The closures which are necessary to allow essential resurfacing operations to be carried out will continue until 31st october 1981.

Alternative Routes for Traffic:-

While such closures are in operation traffic will either be confined to a single lane width, with or without opposing traffic in the adjacent lane or, where necessary, be directed on to an alternative route indicated by appropriate traffic signs.
