#### **TENDERS FOR TREASURY BILLS**

#### THE TRUNK ROADS (ROUTE A74) (STRATHCLYDE REGION) (TEMPORARY RESTRICTION OF TRAFFIC) **ORDER 1982**

THE Secretary of State gives notice that he proposes to make the Order extending for a further 1 year restrictions to traffic on lengths of the trunk road (Route A74) in Strathclyde Region. To enable roadworks to be carried out on lengths of the road from the Dumfries and Galloway Regional Boundary to the end of Route A74 at its junction with the Draffan-Stonehouse Road (unclassified) at Blackwood it will be necessary to restrict traffic from time to time by closures of one carriageway or one lane of a carriageway. While such closures are in operation traffic will be confined to a single lane width, with or without opposing traffic on the adjacent lane. cover closures over the period up to 30th April 1983.

Intending users of the route with vehicles or loads exceeding 2.9 metres in width should, in addition to the normal notification procedure, confirm with the Strathclyde Police the suitability of the route on the particular day of the journey.

## THE TRUNK ROADS (ROUTE A75) (MAXWELLTOWN RAILWAY BRIDGE) (TEMPORARY CLOSURE) ORDER 1982

1st March 1982.

- All landings of sheep shall be in accordance with the provisions of the Importation of Animals Order 1977 and with the following provisions of this licence.
- 2. Shipment must be direct from the Isle of Man to Great Britain.
- The sheep, shall immediately be taken under the terms of the Importation Order, to an approved Reception Centre linked with that port or airport as specified below:—

Port of Landing

Linked with Reception Centre

Cairnryan Stranraer

linked with

Cairnryan Lairage, Cairnryan, Wigtownshire.

The sheep shall be accompanied by a certificate, signed by a duly authorised veterinary surgeon of the Government of the Isle of Man, giving the description, breed, ear number, sex and age of the sheep and certifying that:—

- Sheep scab is compulsorily notifiable according to Manx legislation and has not been recorded on the Isle of Man during the 24 month period preceding export of the sheep.
- For sheep to be exported from flocks containing non-indigenous sheep.
  - (a) All sheep over the age of 12 months in the flock(s) of origin of the sheep to be exported were sampled for testing by the agar gel immunodiffusion test (AGIDT) or the enzymelinked immunosorbent assay (ELISA) for maedi/visna with negative results during the 3 months prior to export;
  - (b) the sheep to be exported were subjected to sampling for submission to the agar gel immuno diffusion test (AGIDT) or the enzyme-linked immunosorbent assay (ELISA) for maedi/visna with negative results during the 30 days prior to export.
- 3. Within 21 days prior to the intended date of export, the sheep to be exported were totally immersed in an approved dip containing an active principle effective against ectoparasites including Psoroptes communis var ovis and Sarcoptes scabei var ovis, to the satisfaction of the duly authorised veterinary officer.

- On examination at the time of shipment to Great Britain the sheep showed no evidence of infectious or contagious disease, including ecto parasitism and were fit to travel.
- 5. The sheep were moved from their premises of origin to the point of export without coming into contact with animals not similarly certified, and prior to loading all vehicles used had been thoroughly cleansed and disinfected.

#### NOTES:

- Any person wishing to land animals in Great Britain under the terms of this licence must make arrangements in advance, with the occupier of the reception centre to which the animals are intended to be taken after landing, for accommodation of the animals
- The carrier of imported animals, must in accordance with Article 4(7) of the Importation of Animals Order 1977, notify the person in charge of the approved reception centre to which those animals are licensed to be moved of the proposed time of landing of those animals, and of their number and description.
