## (ROUTE M74) (JUNCTION 4-A723 INTERCHANGE) (TEMPORARY CLOSURE OF CARLISLE/MOTHERWELL **SLIP ROAD) ORDER 1982**

THE Secretary of State gives notice that he has made the above Order temporarily closing that length of the Carlisle/Motherwell slip road at M74/A723 Interchange (Junction No. 4) from the point on the west kerbline at which the said slip road exits from the London-Carlisle-Glasgow-Inverness Trunk Road (Route A74) to the point at which it merges with the Hamilton/Motherwell Principal Road (Route A723). a distance of 1000 metres.

## THE TRUNK ROADS (ROUTE A78) (KILWINNING BYPASS) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 1982
