TENDERS FOR TREASURY BILLS

(Being a multiple of one new halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- Tenders must be made through a London Banker, Discount House or Broker.
- Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- Tenders must be made on the printed forms which may be obtained from the Bank of England.
- The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

Treasury Minute dated 3rd November 1982

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 3rd November 1982 and until the coming into operation of a further determination;

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the banking day preceding the date the principal is credited to the account of the authority's banker;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
- III. The rates of such interest shall be:—

EXPLANATORY NOTE

These regulations amend the Supplementary Benefit (Resources) Regulations 1981.

They propose a special disregard on the income from an adoption allowance payable to a family in receipt of supplementary benefit. Local authorities are now able under Section 32 of the Children Act 1975 to submit schemes for the payment of allowances in certain circumstances to people who adopt children. A family in receipt of supplementary benefit would at present benefit by only £4.00 of such an allowance. To ensure that they are no worse off than other families receiving the allowance it is proposed to disregard any amount of the allowance which exceeds the total of the supplementary benefit payable in respect of the child.
