#### NOTES:

1. The following diseases were eradicated from Great Britain in the years indicated: cattle plague or rinderpest (*pestis bovina*), 1877; epizootic lymphangitis (*lymphangitis epizootica*), 1906; equine infectious anaemia (*anaemia infectiosa equorum*), 1976; fowl plague (*pestis avium*), 1979; glanders (including farcy) (*malleus*), 1928; Newcastle disease (*pseudo-pestis avium*), 1978; parasitic mange (*scabies parasitica*), 1977; pleuropneumonia (*pleuropneumonia contagiosa bovis*), 1898; rabies (*lyssa*), 1970; sheep pox (*variola ovina*), 1866 and swine fever (*pestis suum*), 1971.

2. The following diseases have never been recorded in Great Britain: African horse sickness (*pestis equorum*), African swine fever (*pestis suum africana*), blue tongue (*febris catarrhalis ovium*) dourine (*exanthema coitale paralyticum*), equine encephalomyelitis (*meningo-encephalomyelitis enzootica eq.*), lumpy skin disease (*dermatosis nodularis*) and Teschen disease (*encephalomyelitis enzootica suum*).

3. The figures for animals slaughtered for Aujeszky's disease refers to 255 outbreaks confirmed after the commencement of the Aujeszky's disease control and eradication scheme on 14 March 1983. The other five outbreaks were confirmed in the period 1 January to 14 March, prior to the commencement of the scheme. (20 SI)

THE CONVERSION OF HIGHWAY (DUNFERMLINE DISTRICT) (QUEEN ANNE STREET, DUNFERMLINE) ORDER 1983

THE Dunfermline District Council, in exercise of the powers conferred on them by Section 201 of the Town and Country Planning (Scotland) Act 1972 and of all other powers enabling them in that behalf, having complied with the provisions of Section 206 of that Act, hereby confirm the following Order:

1. This Order may be cited as the Conversion of Highway (Dunfermline District) (Queen Anne Street, Dunfermline) Order 1983 and shall come into operation on 11th July 1983.
2. In this Order "highway" means the highway situated in the District of Dunfermline and comprising that length of Queen Anne Street, Dunfermline, extending in a west-east direction from its junction with Douglas Street to a point 21.7 metres or thereby east of that junction (being highway over which the public have right of way with vehicles, but not trunk roads or roads classified as principal roads for the purposes of advances under Section 8 of the Development and Road Improvement Funds Act 1909).
3. Whereas the Dunfermline District Council have by resolution adopted a proposal for improving the amenity of part of their area being a proposal which involves highway in that area being changed to footpath, it is hereby provided that any right which persons may have to use vehicles on the highway is extinguished.
4. Notwithstanding the provisions of article 3 of this order, it is hereby provided that the use on the highway of vehicles (whether mechanically propelled or not) of the following descriptions and in the following circumstances is permitted:
  - (a) for the conveyance of goods, merchandise and refuse to or from any premises situated in or adjacent to any of said lengths of road, but such vehicle shall only wait on that part of a restricted road at which the Council have caused to be erected or placed a traffic sign or signs indicating that that part of the road is a loading area.

- (b) for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation, building maintenance or demolition in or adjacent to that length of road, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road specified, or the laying, erection, alteration or repair in or adjacent to any of the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act 1878.
- (c) to enable a funeral director or other owner of vehicles to use said vehicles as part of a funeral cortege, or otherwise in connection with a funeral.
- (d) to enable vehicles to be used as part of a wedding party or otherwise in connection with a wedding at Erskine Parish Church.
- (e) if said vehicle is being used for Fire Brigade purposes, or is an ambulance or is a Local Authority or Police vehicle being used in pursuance of statutory powers or duties.
- (f) if said vehicle is being used for the carriage of a disabled person and on which there is displayed in the relevant position a Disabled Person's badge issued by a Local Authority in exercise of its powers under Section 21(1) of the Chronically Sick and Disabled Persons Act 1970.
5. Where immediately before the date of coming into operation of this Order, there are any rights of statutory undertakers in respect of any apparatus of theirs which is under, in, on, over, along or across the highway such undertakers shall thereafter without prejudice to the provisions of Section 219 of the Town and Country Planning (Scotland) Act 1972 as read with Sections 32(3) and (4) of the Mineral Workings Act 1951, have the same rights in respect of that apparatus as they had immediately before that date.
