TENDERS FOR TREASURY BILLS

- THE Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Securities Office, Bank of England, Threadneedle Street, on Friday, 16th March 1984, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £100,000,000.
- The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the tenderer on any business day from Monday, 19th March 1984 to Friday, 23rd March 1984 inclusive and will be due 91 days after date.

Each Tender must be for an amount of not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent (being a multiple of one halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

- Tenders must be made on the printed forms which may be obtained from the Bank of England.
- The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

CONSULTATIVE DRAFT

What is a Structure Plan?

A Structure Plan is the Council strategy for the use and development of land in Strathclyde. It was approved by the Secretary of State with effect from 23rd January 1981. Subsequently a First Review was approved on 21st April 1983.

What is the Second Review?

The Council monitors the Structure Plan annually to assess its performance, and publishes the results (see Structure Plan Monitoring Reports 1980, 1982 and 1983).

The Council also reviews the Plan on a biennial basis to refine or update policies and proposals as necessary to ensure their continued effectiveness.

The content of the Second Review

The content of the Second Review falls into 2 main categories:

- (1) The monitoring of approved policies and their review and further development as necessary. This includes, particularly, Urban Renewal priorities, public and private sector Housing, Industrial Land and Floorspace, certain aspects of Transportation, such as city centre roads and car parking policy, and Shopping.
- (2) New Policy Areas, including Minerals (other than mineral aggregates which are included in the approved Structure Plan), Heritage (including Archaeology), Urban Sport and Recreation and some aspects of Urban nature Conservation.

Can the people have a say in what happens next?

Yes. At present the Second Review is in darft form as a basis for consultation with District Councils, Interest Groups, Community Councils and individuals. All are encouraged to give their views and they will be considered when the final draft is drawn up in the Autumn of this year.

How will people be able to have their say?

Copies of the Consultative Draft will be available at all public libraries, District Council Headquarters and Regional Council Headquarters (at Glasgow, Paisley, Hamilton, Dumbarton, Ayr and Lochgilphead).
