AGRICULTURAL MARKETING ACT 1958

ABERDEEN AND DISTRICT MILK MARKETING SCHEME 1984

IN terms of Section 2(12) of the Agricultural Marketing Act 1958, the Secretary of State hereby gives notice of the Aberdeen and District Milk Marketing Scheme 1984 Approval Order 1984, the principal provisions of which appear below:—

THE ABERDEEN AND DISTRICT MILK MARKETING SCHEME 1984 APPROVAL ORDER 1984

Coming into Operation 1st April 1984

Whereas by virtue of the powers conferred on it by Section 1 of the Agricultural Marketing Act 1958 ("the Act") the Aberdeen and District Milk Marketing Board being the board administering the Aberdeen and District Milk Marketing Scheme 1933 revoked by the substitutional scheme hereinafter referred to, after publication in the prescribed manner and without a poll in terms of Section 1(4) of the Act having been demanded has submitted to me a substitutional scheme regulating the marketing of milk entitled the Aberdeen and District Milk Marketing Scheme 1984 ("the substitutional scheme"); And whereas in accordance with the provisions of Section 2(1) of the Act, I duly caused to be published in The Edinburgh Gazette a Notice stating that the substitutional scheme had been submitted to me and specifying (1) the place where copies of the substitutional scheme might be obtained and inspected and (2) the period within which objections and representations with respect to the substitutional scheme might be made;

And whereas no such objections or representations with respect to the substitutional scheme were duly made;

And whereas after (1) considering the substitutional scheme duly submitted to me (2) giving notice of proposed modifications in accordance with Section 2(6) of the Act and (3) more than half the persons nominated in accordance with the provisions of the said Section 2(6) having notified me that they assented to the proposed modifications, by virtue of the powers conferred on me by Section 2(4) of the Act, I made certain modifications to the substitutional scheme;

And whereas being satisfied after making such modifications as aforesaid that the substitutional scheme would conduce to the more efficient production and marketing of milk, I laid before Parliament a report showing that the provisions of Section 1(4) of the Act had been complied with together with a draft of the substitutional scheme as set out in the Schedule to this Order, which draft was approved by each House of Parliament:

Now therefore in exercise of the powers conferred on me by the said Section 2 and of all other powers enabling me in that behalf, I hereby make the following Order:—

Citation and commencement

1. This Order may be cited as the Aberdeen and District Milk Marketing Scheme 1984 Approval Order 1984 and shall come into operation on 1st April 1984.

Approval and commencement of the substitutional scheme

2. The Aberdeen and District Milk Marketing Scheme 1984 set out in the Schedule to this Order is hereby approved and shall come into force on 1st April 1984.

Declaration

3. The Aberdeen and District Milk Marketing Scheme 1984 set out in the Schedule to this Order is hereby declared for the purposes of Section 52(2) of the Act to be a substitutional scheme.

3(2) of the Importation of Animals Order 1977, hereby authorises the

landing in Great Britain, in accordance with the conditions set out below of, cattle 15 days of age and over originating in the Republic of Ireland

(b) for deposits of less than £100,000: 8³/₄ per cent if the deposit is applied in payment of a scheduled liability and 7 per cent if the deposit is withdrawn for cash.

For deposits made under earlier Prospectuses (Series 4 and 5) which reach the second or fourth anniversary of the deposits, as applicable, in accordance with the terms and conditions set out therein: $9\frac{1}{2}$ per cent if the deposit is applied in payment of a scheduled liability, and 7 per cent if the deposit is withdrawn for cash. Information on Certificates of Tax

Scotland General Import Licence No. 23 dated 31st October 1979 is hereby revoked. This licence is valid until varied or revoked by the Secretary of State.

CONDITIONS

- 1. All landings of cattle shall be in accordance with the provisions of the Importation of Animals Order 1977 and with the following provisions of this licence.

- 3. (a) Each consignment of cattle shall be accompanied by the following certificates signed by a veterinary officer appointed by the Government of the Republic of Ireland.
 - a certificate in accordance with Annex F, Model I of the EEC Directive 64/432 (as amended).
 - (ii) a certificate as in the attached Annex.
 - (b) Cattle from OBF herds and over 12 months of age must have passed the serum agglutination test (SAT) for brucellosis (at less than 30 IU's) within 30 days prior to loading. (See NOTE below regarding castrates).
 - (c) Cattle from BF herds must have passed the SAT for brucellosis (at less than 30 IU's) within 30 days prior to loading, and in the case of females
 - (i) be unvaccinated against brucellosis
 - (ii) be non pregnant
 - (iii) show no erupted permanent incisor teeth.
 - (d) Cattle from herds of neither OBF nor BF status must
 - (i) be intended for meat production (further fattening)
 - (ii) be under 30 months old
 - (iii) be entire males or castrates (see note regarding castrates)
 - (iv) if over 30 days old have passed the SAT for brucellosis (at less than 30 IU's) within 30 days prior to loading (see the NOTE below regarding castrates).
 - (e) Cattle must derive from an officially tuberculosis free herd and if over 6 weeks old must have reacted negatively to the single intradermal tuberculin test using bovine tuberculin within 30 days prior to loading and interpreted in accordance with Annex B of Directive 64/432.

Cattle for Slaughter

- 4. (a) Each consignment of cattle shall be accompanied by a certificate in accordance with Annex F, Model II of the EEC Directive 64/432 and signed by a veterinary officer appointed by the Government of the Republic of Ireland.
 - (b) Cattle from herds of neither OBF nor BF status and over the age of 4 months, must have passed the SAT for brucellosis (at less than 30 IU's) within 30 days prior to loading (see note below regarding castrates).
 - (c) Cattle from herds not officially tuberculosis free and over the age of 4 months must within 30 days prior to loading have reacted negatively to the single intradermal tuberculin test using bovine tuberculin and interpreted in accordance with Annex B of Directive 64/432.
- 5. The cattle in the categories described at paragraphs 4(b) and 4(c) must be shipped direct from ROI to Great Britain.
- 6. Officially brucellosis free (OBF) and brucellosis free (BF) cattle must be kept serarate from each other and must not come into contact with other animals not similarly certified. Failure to observe this requirement will result in all the animals being classified in the lowest status.
- 7. Any person wishing to land animals in Great Britain under the terms of this licence must make arrangements for accommodation of the animals in advance with the person in charge of the reception centre to which the animals are to be taken after landing.
- 8. The carrier of imported animals must notify the person in charge of the reception centre of the proposed time of landing, the number of animals and their description.

NOTE: Male cattle castrated before the age of 4 months are exempt from the SAT (at less than 30 IU's) unless they are over 12 months old and from an OBF herd and are destined to join an OBF herd in Great Britain.

- *(b) The cattle are derived from Officially Brucellosis Free herds.
- *(c) The cattle are derived from Brucellosis Free herds. As far as can be determined and to the best of my knowledge and belief the female cattle to be exported have not been vaccinated against brucellosis (see note).
- (d) The cattle were examined by a Veterinary Officer at the time of loading and the female showed no erupted incisor teeth.
- (e) A certificate from an approved Veterinary Surgeon has been received to the effect that cattle are non-pregnant.
- *(f) The cattle are not derived from Officially Brucellosis Free nor Brucellosis Free herds and are intended for further fattening. They were examined by a Veterinary Officer within 30 days of loading who certified that they were under 30 months of age and were:
 - (i) castrates or
 - (ii) entire males and those of which are over 30 days old have passed the SAT for brucellosis (at less than 30 IU's).
- (g) notwithstanding Point V(d) of the EEC Certificate, males castrated before the age of 4 months have not been subjected to a serum agglutination test for brucellosis.
