TENDERS FOR TREASURY BILLS

- THE Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Securities Office, Bank of England, Threadneedle Street, on Friday, 28th September 1984, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £100,000,000.
- The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the tenderer on any business day from Monday, 1st October 1984 to Friday, 5th October 1984 inclusive and will be due 91 days after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount of not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent (being a multiple of one halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- Tenders must be made on the printed forms which may be obtained from the Bank of England.
- The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

THE Secretary of State, in exercise of his powers under Section 11(1)(a) of the COMPETITION ACT 1980, hereby refers to the Monopolies and Mergers Commission the questions set out below relating to the efficiency and costs of the British Railways Board in its property activities.

For the purpose of this reference:-

- (a) "land" includes buildings on and air space over land; and
- (b) "property activities" means activities in the acquisition, management, development and disposal of land, whether or not owned by the Board, but excluding land forming part of the estate of any enterprise of the Board or of any of its subsidiaries which is an enterprise whose proposed sale has been announced.

The commission shall upon this reference investigate and report on the following questions:-

- (i) whether the Board could improve its efficiency and thereby reduce its costs in the exercise of its property activities, with particular reference to:
 - the criteria according to which and procedures by which decisions are taken in the exercise of those activities, including the criteria according to which land is made available for development and/or disposal;
 - (b) the scope for development and/or disposal of land in respect of which it exercises those activities;
 - (c) the scope for increased private sector finance for and participation in those activities;
 - (d) its policy in relation to charges made in the exercise of those activities;
 - (e) the Board's internal management information systems, including those for attributing to a particular part of the enterprise of the Board and its subsidiaries the cost of land used in that part;
 - (f) whether the present manner of exercise by the Board of those activities and relationship between that exercise and the exercise of the other activities of the Board and its subsidiaries is in the best financial interest of the Board and its subsidiaries taken as a whole;
 - (g) the scope for increased commercial use of sites on stations; and

- (h) its policy in relation to and management of non-operational land which, by reason of its physical characteristics or location, has little or no development potential; and
- (ii) whether, in relation to any matter falling within the question set out above, the Board is pursuing a course of conduct which operates against the public interest.

The Commission shall report upon these references within a period of six months beginning on the date hereof.

TREASURY MINUTE dated 26th September 1984

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are per-

mitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 26th September 1984 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
- III. The rates of such interest shall be:-

THE KINCARDINE-KIRKCALDY-ST ANDREWS TRUNK ROAD (EAST FIFE REGIONAL ROAD — PHASE II — COWDENBEATH TO LOCHGELLY) COMPULSORY PURCHASE ORDER 1984

NOTICE is hereby given that the Secretary of State in exercise of the powers conferred on him by the above mentioned Acts has made a Compulsory Purchase Order entitled The Kincardine-Kirkcaldy-St Andrews Trunk Road (East Fife Regional Road — Phase II — Cowdenbeath to Lochgelly) Compulsory Purchase Order 1984.

The Order provides for the purchase of the lands described in the Schedule hereto for the purpose of construction a new length of the Kincardine-Kirkcaldy-St Andrews Trunk Road.

A copy of the Order and of the map referred to therein may be inspected free of charge at all reasonable hours from 28th September 1984 to 9th November 1984 at the offices of the Scottish Development Department, New St Andrew's House, Edinburgh EH1 3SZ; the offices of Fife Regional Council, Fife House, Glenrothes; Dunfermline District Council, City Chambers, Dunfermline and The Town House, Cowdenbeath.

The Order as made becomes operative on 28th September 1984 but if application is made to the Court of Session under paragraph 15 of the First Schedule to the Acquisition of Land (Authorisation Procedure) (Scotland) Act 1947, as extended by Section 60 of the Land Compensation (Scotland) Act 1973 within a period of six weeks function that date by any person aggrieved by the Order who desires to question the validity thereof the Court of Session may, by interim order, suspend the operation of the Order or any provision contained therein, either generally or insofar as it affects any property of the applicant and may, if satisfied that the authorisation granted by the Order is not empowered to be granted or that the interests of the applicant have been substantially prejudiced by any requirement of the said Schedule or of any regulation made thereunder not having been complied with, quash the Order or any provisions contained therein either generally or insofar as it affects any property of the applicant.

The Secretary of State may acquire the land and the rights in the land to which this notice relates by a General Vesting Declaration under Section 278 of the Town and Country Planning (Scotland) Act 1972. The effect of the making of such a declaration is to vest the land and rights in the land in the Secretary of State at the end of the appropriate period and is more fully explained in Form 9 of The Compulsory Purchase of Land (Scotland) Regulations 1976 (SI 1976 No 820). A copy of the said Regulations has also been deposited and may be seen as aforesaid.
