CALLING IN ALL COINS OF THE DENOMINATION OF ONE HALFPENNY

ELIZABETH R.

WHEREAS under Section 3(1)(e) of the Coinage Act 1971, We have power by Proclamation made with the advice of our Privy Council to call in coins of any denomination:

And Whereas it now appears to Us desirable to call in all coins of the denomination of one halfpenny:

We, therefore, with the advice of Our Privy Council and in pursuance of Section 3(1)(e) of the Coinage Act 1971, do hereby call in by thirty-first day of December One thousand nine hundred and eighty-four all coins of the denomination of one halfpenny, and accordingly after such thirty-first day of December One thousand nine hundred and eighty-four such coins shall not be current or legal tender within Our United Kingdom of Great Britain and Northern Ireland.

Given at Our Court at Buckingham Palace, this twenty-second day of November in the year of our Lord One thousand and eighty-four and in the thirty-third year of Our Reign. The following Notice was taken from The London Gazette of Tuesday, 27th November 1984.

TENDERS FOR TREASURY BILLS

Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

- The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.
