## TENDERS FOR TREASURY BILLS

- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount of not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent (being a multiple of one halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

This Order, which came into operation on 31st July, further amends the Diseases of Animals (Approved Disinfectants) Order 1978, by adding to the list of approved disinfectants in that order, those newly approved disinfectants which are mentioned in Schedule 1 to this Order and by deleting from that list the disinfectants mentioned in Schedule 2 (Article 3(1) and (2)). The disinfectants deleted may, however, continue to be used as approved disinfectants until 31st December 1985 (Article 3(3) and (4)).

## THE IMPORT AND EXPORT (PLANT HEALTH)

## (GREAT BRITAIN) (AMENDMENT) (No. 2)

## **ORDER 1985**

This Order, which comes into effect on 1st September, amends the Import and Export (Plant Health) (Great Britain) Order 1980, by prohibiting the landing in Great Britain of any used agricultural machinery unless it is cleaned to remove all particles of soil and other debris (Article 2(1)). The Order also subjects the landing of seed potatoes to an additional condition by requiring consignments of seed potatoes to be accompanied by an official statement that the potatoes were grown in an area of production in which Rhizomania disease (caused by beet necrotic yellow vein virus) has not been known to occur (Article 2(2)).

The Post Office, by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969 and all other powers enabling it in this behalf, hereby makes the following Scheme:

## Commencement and citation

- 1. This Scheme:
  - (a) shall come into operation on 2nd September 1985;
  - (b) may be cited as the Post Office (Postal Order) Amendment (No. 16) Scheme 1985;
  - (c) shall be read as one with the Post Office (Postal Order) Scheme 1971 (Post Office Scheme P5/1971) (hereinafter called "the Scheme"), the Post Office (Postal Order) Amendment (No. 1) Scheme 1973 (Post Office Scheme P4/ 1973) and the Post Office (Postal Order) Amendment (No. 15) Scheme 1984 (Post Office Scheme P5/1984).

#### Issue and amounts of postal orders

- 2. For sub-paragraph (1) of paragraph 4 of the Scheme there shall be substituted the following:-
  - "(1) Postal Orders may be issued for the following sums:
    - (a) any multiple of 5 pence up to and including 50 pence;
    - (b) the sum of 60 pence, 70 pence, 75 pence, 80 pence, 90 pence and one pound;
    - (c) any sum greater than one pound as the Post Office may from time to time determine."
