### FORESTRY COMMISSION

THE Forestry Commissioners hereby give notice that they have made an Order under the Plant Health Act 1967 entitled the Tree Pests (Great Britain) (Amendment) Order 1986.

The Order amends Article 3(1)(a)(i) of the Tree Pests (Great Britain) Order 1980, as amended, (which referred to the keeping etc of non-indigenous tree pests and plants and wood carrying such pests) so as to prohibit the keeping etc without a licence of any tree pest mentioned in Schedule 1 or 2 to the Import and Export of Trees, Wood and Bark (Health) (Great Britain) Order 1980. It also provides for the purposes of Articles 5 and 6 of the Tree Pests (Great Britain) Order 1980 a new definition of "non-indigenous tree pest" so as to comprise all the tree pests mentioned in Schedules 1 and 2 to the Import and Export of Trees, Wood and Bark (Health) (Great Britain) Order 1980 and any other tree pests which are not normally present in Great Britain and in respect of which there is in the opinion of an inspector an imminent danger of their spreading or being spread in Great Britain.

The Order will come into operation on 10th March 1986 and has been published as Statutory Instrument No 197.

### FORESTRY COMMISSION
