The letters must be 0.8 cm high and the figures 1 cm high. The health mark may include an indication of the official veterinarian who carried out the health inspection of the meat.

(B) For meat products, including canned meat but excluding meat products derived in whole or in part from poultry meat, the health mark shall consist of:—
