AUTHORITY GIVEN UNDER SECTION 7 OF THE
WIRELESS TELEGRAPHY ACT 1967

WHEREAS: A. the import of certain wireless telegraphy apparatus is restricted by the Wireless Telegraphy (Citizens' Band and Amateur Apparatus) (Various Provisions) Order 1988 (a) (the "Order"); and
B. the Secretary of State is satisfied that this Authority and the terms and conditions attached to it are compatible with the international obligations of the United Kingdom:

THEREFORE THE SECRETARY OF STATE, in exercise of the powers conferred on him by section 7 of the Wireless Telegraphy Act 1967 (c.72), gives his authority to any person to import the Apparatus described in paragraph 1 into the United Kingdom and to keep it in his custody and control, subject to the terms and conditions specified in paragraphs 2 and 3.

1. This Authority applies to CB apparatus which operates on any of the frequencies specified in paragraph 1.3 of Part A of MPT 1333, which has been approved by a country listed in the Annex to Schedule 2 to the Order and marked in accordance with that Schedule and which complies in all respects with the Order save that it is not for the time being approved under section 84 of the Telecommunications Act 1984 (the "Apparatus").
2. The Apparatus shall not be sold, let on hire, or offered or advertised for sale or hire in the United Kingdom unless it is approved by the Secretary of State in accordance with article 3(1)(c) of the Order.
3. This Authority shall remain in force until it is revoked by the Secretary of State with or without notice.
4. Words and expressions used in this Authority shall have the same meaning as they have in the Order.
5. The Interpretation Act 1978 shall apply for the purposes of interpreting this Authority as if it were an Act of Parliament.

EXPLANATORY NOTE

This Authority allows the import of CB apparatus which falls within the purview of MPT 1333 and which has been type approved by a State which belongs to the European Conference of Postal and Telecommunications Administration (CEPT) but which has not been type approved by the Secretary of State (the "Apparatus"). Following import, the Apparatus must be type approved before it can be sold, let on hire or offered or advertised for sale or hire in the United Kingdom.

Those persons wishing to import CB apparatus which has not been approved by any CEPT member State must first apply for (and be granted) an individual authority to import under section 7 of the Wireless Telegraphy Act 1967 by writing to the Department of Trade and Industry, Radiocommunications Division, Room 102, Waterloo Bridge House, Waterloo Road, London SE1 8UA. Such authority may be granted by the Secretary of State at his discretion.

TREASURY MINUTE dated 10th August 1988

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quotas at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 10th August 1988 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.) or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
